The Police Electronic Records Management Service (PERMS) is a service provided by the Belize Police Department to citizens who wish to validate their personal judicial information.

Police record information can only be accessed once the terms and conditions outlined below are accepted.

Access is intended for users who are at least 18 years old. Persons under the age of 18 are not permitted to access and use the Website and its Content.

Purpose and Scope

The use of the information provided by the Belize Police Department is limited to personal use only. You may download publicly available Content from this Website only for your personal, non-commercial use, provided that you keep intact all copyright and other proprietary notices.
